#### Financial Report:

Shara Shumway: Rena asked if we could supply her with a receipt book for when the Farmers Market starts.

Glenna Wade: What did we agree on to charge her (Rena) to do the Market?

Shara Shumway: \$50 or 65.00 to cover the utility's. She already has a few vendors lined up

Barbara Ferrando: To pay the water bill.

Glenna Wade: I think we are going to see how it goes like the first 2 or 3 mos. And then go from

there. How about you (Shara) deal with that?

#### Library:

Carl Shumway: How long is the agreement with the Library now?, and what do they pay?

Glenna Wade: I believe its a year to year and it was rented for \$1800.00 a year

Carl Shumway: You need that space. They are not going to do it until you give then a dead line to get out. They are over \$40 Million behind the maintenance in Lakeview, they are not going to spend money in Christmas Valley until you give them a dead line. A letter giving them 2 years? We have been trying since the mid 1990's to get them to put money into a fund. That money that has been raised here is going into the Library in Lakeview. Lakeview collects like \$450K per year, what they are getting from you is really Free Rent here. The library building here was only a temporary place because we didn't have one at the time. It was not meant to be permanet. This building (office) should be a pro shop.

Shara Shumway: Maybe we should send them a letter.

Glenna Wade: We are encouraging them to take the funds they have raised and the money they have saved by renting the now library to start building. Even if we said by the year of 2025 that gives them 5 years to get it together, build a building. I know that over the years this community has raised over \$25K.

Shara Shumway: That's not what their records show!

#### Community Hall:

Shara Shumway: Are you having anymore leaks over there?

Barbara Ferrando: No, well just the same one as last year. Its in the men's bathroom against the wall. Its the snow because its not always there.

#### Airport:

Glenna Wade: Does anyone know about the light thats kind of behind the east maybe 4ft and south 20ft that flashes? Need to see if maybe its going out?

#### Lake:

Community Service tried to burn the cat tail but it was to wet.

Geese are starting to pair up.

Need to work on water testing and cat tail control

Carl explains how the water fall worked and when water shot out it made effects that people liked and it moved the water and helped with the algae

Lisa Cooper: Mid state will be shutting down the power to the pump-house for while they are working on the power lines

by Shara Shumway to at least Advertise for a Job Opening It was seconded by Barbara Ferrando





## What are the primary safety concerns today?

Nails, weed eaters, nails, hammers, nails, rakes, nails

The rodeo grounds is in disrepair and that is why we are here. We want the workday to be fun but safety must be and will be a focus at all times!!

Nails are rusty and tetanus is on the rise in Oregon. Walk with an abundance of caution, know where you are putting your feet; watch for boards laying on the ground with nails sticking up or nails sticking out from fencing where rails used to be. Don't walk on them, don't stab yourself with them

Anyone swinging a hammer make sure you hit the nail not your thumb.

Rakes, as a rule, are accident free—no pole vaulting—proper tools for the proper job!!!

Check weed eater for defects. Weed eaters are called eaters because they have moving parts that can eat your toes, or other body parts; so again, abundance of caution. Anyone using a weed eater will wear boots—no open toe sandals or the such. No one within 10' of a weed eater in operation; approach a weed eater operator from the front so they can see you and shut off the weed eater.

If I am injured, I will report it to a committee member—there are forms to complete!!

Safety equipment will be worn and returned to the Foundation at the end of the day

Lastly, I understand there is no 'horse play'. I will receive one warning and the second offense I will be told to leave...
